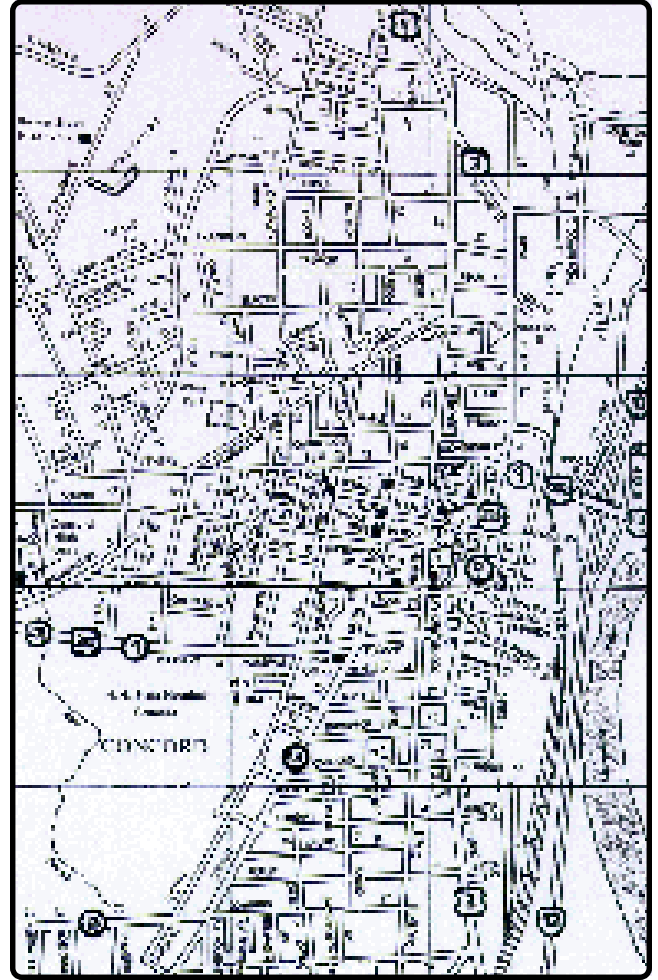

## NH Conservatives Unify Against Judicial Activism

On November 23, 1999, the Coalition of New Hampshire Taxpayers held a press conference at the Legislative Office Building in Concord to repudiate the Claremont Supreme Court decision and to lobby for local control of education. Conservative groups from around the state were invited to participate.

Representatives from each group were asked to give a one-minute speech on the subject of local control of education and taxes. Although NH Right to Life does not take a position on either of these two issues, NHRTL President Philip Morrison chose to participate. His following remarks justify NHRTL involvement:

Good afternoon. My name is Philip Morrison and I am here representing New Hampshire Right to Life. Now, New Hampshire Right to Life is an organization that is not normally associated with the issues of education or taxes. The goal of our organization is to restore legal protection to preborn babies. But I am not here to agree with these other organizations as to what is the best way to solve the education funding dilemma or whether all issues should be subject to local control. Rather, I am here to join with these other organizations in denouncing a common enemy: judicial activism.

With increasing regularity, the judiciary distorts our Constitution while the executive and legislative branches stand idly by. Many judges, such as the

## The Future Generation

## SMB Foundation Hosts

### Pro-Abort Candidate Al Gore

NHRTL picketed presidential candidate Al Gore in October at a function hosted by a non-profit credit union organization historically associated with St. Mary's Bank. The credit union organization called "SMB Charitable Foundation" was seeking to raise funds for their Credit Union Museum by hosting the pro-abortion candidate Al Gore.

"Deep disappointment was expressed with St. Mary's Credit Union for promoting this visit and the link of Mr. Gore to the 'culture of death' so decried by Pope John Paul II," said NHRTL trustee Kathleen Souza in a press release. "Members of St. Mary's are rightly insulted that their institution has used its resources and good name to honor such an anti-life Al Gore."

I am writing you to express my support of an exemplary pro-life candidate for the Presidency of the United States of America, Ambassador Alan Keyes.



**Sen. Bob Smith:  
PRO-LIFE CHAMPION!**

Sen. Bob Smith re-doubled his pro-life efforts in 1999 despite mere casual interest from most GOPers. In particular, his gallant efforts to pass the Partial Birth Abortion Ban Act (**S.1692**) over the veto of pro-abortion President Bill Clinton were frustrated for the third time. Smith once again gave vigorous testimony to the whole Senate on the horrendous procedure on Oct. 21, 1999.

Sen. Smith also has a genuine pro-life Human Life Amendment (HLA) bill awaiting more co-sponsorship from other Senators who frequently claim the pro-life title. **S.907** has so far only gained co-sponsorship from Sen. Jesse Helms. NHRTL is very pleased with S.907 because it is a "no-exceptions, no-compromise" Human Life Amendment to the Constitution.

Sen. Bob Smith saw fit to defend the babies with stirring, albeit gruesome, testimony about an unholy alliance. The abortion clinics, large companies, and shady "wholesaler-harvester" outfits are trafficking in fetal parts from aborted babies.

Smith reported that "harvester" companies hire "technicians" to remain on site at the abortuary and get the baby parts requested by the big pharmaceutical companies and others. It is illegal to sell baby parts, so the parts are mailed about "for free" but the abortuary charges high prices for on-site office space and "lab access fees". One company, Opening Lines of West Frankfurt, IL, published a listing of body parts:

- Brain**.....\$ 999      **Liver**.....\$ 150
- Trunk** (with or without arms)....\$ 500
- Spinal Chord**.....\$ 325

**Sen. Judd Gregg:  
Where Were You?**

NH Sen. Judd Gregg missed several key votes in October on the Partial Birth Abortion Ban, S.1692. He was in Congress at 11:35AM on October 21, 1999 to cast Roll Call vote #336 to table the pro-abortion Harkin amendment to **S.1692**, but the babies still lost 48 to 51. At 2:03PM, Gregg and presidential candidate Sen. John McCain missed roll call vote #337 on the pro-abortion Harkin amendment. It passed 51 to 47.

Gregg missed RC #338, #339 and the final vote on the PBA Ban which failed to override the Clinton veto (63 to 34) by just 3 votes! Gregg, as Deputy Majority Whip, could have focused on the override. His office refused to report why he missed the vote. I dearly hope Gregg was not off campaigning for George W. Bush!

Also, why has Sen. Gregg still not signed on as co-sponsor of Bob Smith's Human Life Amendment **S.907**?

## NH Presidential Primary: February 1

Your vote in the NH Primary can be cast for a candidate who promises to defend the babies, or for a candidate who merely prefers to defend Life. Herein is a very brief overview -- you are implored to research their positions more and make a pro-life selection.

Thankfully, many **Republican Party** candidates hold a pro-life position:

**Gary Bauer**, formerly a Reagan cabinet appointee, has a no-exceptions pro-life position. He supports the whole laundry list of pro-life ideas, including appointment of pro-life judges, no tax-payer funding of abortion, repeal of Roe, and outlawing PBAs. (See pg. 1)

**George W. Bush** wants pro-life votes, but has been unwilling to make any specific promises on behalf of the babies. We do know he would outlaw PBAs. He won't promise pro-life judge nominations. The same decisions which preclude his active pro-life agenda now, if he should gain

office, might preclude pro-life actions in office because then he will be concerned about his own re-election.

**Steve Forbes** is also running as a pro-life candidate. He has made a series of pro-life promises, including pro-life judges, no tax-payer funding, repeal of Roe, and outlawing PBAs. (See pg. 11)

**Alan Keyes**, a former UN Ambassador, has a genuine pro-life agenda which he eloquently promotes everywhere. He always wears the pro-life "Little Feet" pin on his lapel.

**John McCain** has a record of mostly pro-life votes in the US Senate. Still, he has delined to fully embrace a pro-life agenda in his campaign. He recently told the San Francisco Examiner that "in the short term, or even the long term, I would not support repeal of Roe." He has so far declined to co-sponsor Bob Smith's Human Life Amendment S.907.

Pro-abortion candidates **Bill Bradley** and **VP Al Gore** in the

**Democratic Party** are both trying to be more "pro-choice" than the other. Both support tax-payer funding of abortion, US finance of abortions overseas through the UN, and even partial birth abortions -- for starters! Democrats who are genuinely pro-life will have to decide if their pro-life perspective trumps their party affiliation.

Pro-life candidate **Pat Buchanan** is now seeking nomination in the **Reform Party** (which lacks a pro-life plank), and pro-life candidate **Howard Phillips** has clinched the nomination of the pro-life **Constitution Party** (see pg 7). Look for more information on these third party candidates in the fall NHRTL News.

Restoring legal respect for human life could be achieved in just a few short years if we professing pro-lifers would all get out and vote pro-life at every opportunity. Your next chance is February 1. Please make a candidate's pro-life position the highest criterion when you vote. ## Abortionist Concerned About "Discomfort" of "Baby"

George Tiller is infamous for performing *very* late term abortions in Wichita, Kansas. His web site, [www.driller.com/procedure.html](http://www.driller.com/procedure.html) has a chilling sentence: "On the first day of the process, an injection of medication is made into the baby to assure that it will be still-born and will not experience any discomfort during the procedure."

Internet commentator Matt Drudge ([www.drudgereport.com](http://www.drudgereport.com)) sought to use the photo below on his FOX TV show. The photo shows pre-born Samuel Armas after enduring a pre-natal spina bifida operation. Samuel's left hand is reaching out through the womb and clutching the finger of Dr. Joseph Bruner of Vanderbilt University, Nashville. The FOX network executives censored Drudge from using the photo, expecting him to use it to promote a pro-life perspective. Samuel was just 21 weeks old at the time; many abortions are performed after that age. Drudge promptly quit his own show by agreeing with the network to break their contract. Samuel will be born about December 28 in Georgia.

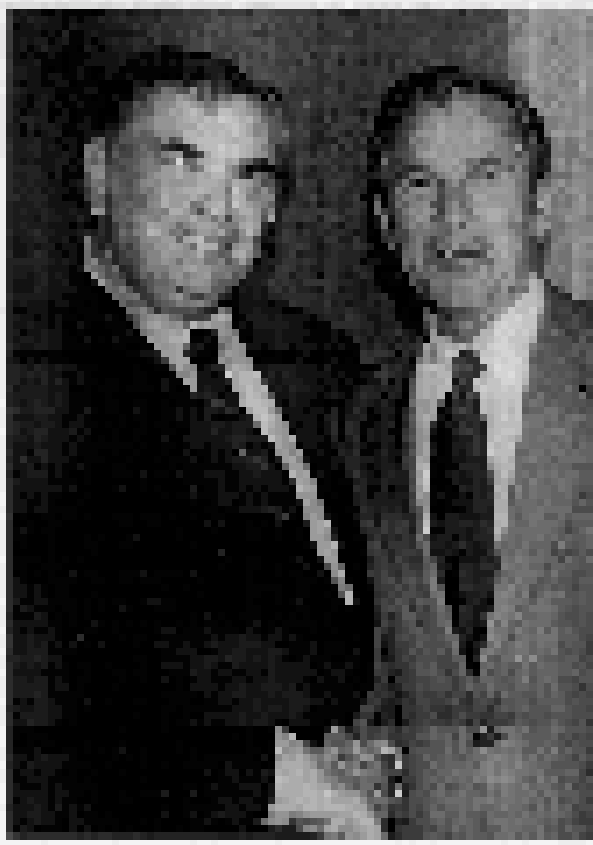

## \*Post-Implantation Abortion and Deceptive Advertisement: An Action Against Planned Parenthood.

When a representative of Ortho-McNeil, one of the largest pill manufacturers, was interviewed by a Protestant Minister, Randy Alcorn, its representative admitted: "We know what an endometrium looks like when it's rich and most receptive to the fertilized egg. When the woman is taking the Pill, you can clearly see the difference, based both on gross appearance - *as seen with the naked eye* - and under a microscope. *At the time*

*when the endometrium would normally accept a fertilized egg, if a woman is taking the Pill it is much less likely to do so.*" — Randy Alcorn, 29-30. This same effect is mentioned in the Leaflet supplied to physicians, but is removed from the "Detailed Patient Package Insert" — a convenient lack of "detail" to women.

### \*Post-Implantation Abortion:

The pill is also designed to work by inducing an artificial "shedding" of the lining of the womb, as an artificially induced "period." This again is abortive. *Contraceptive Tech.*, 14th Ed, 192. The synthetic progesterone in the pill binds to the progesterone receptors, telling the woman's body she has enough progesterone, causing her corpus luteum to cut back its secretion of her own progesterone, and to begin decaying. Studies report corpus luteum deficiencies as a major reason for inadequate endometrium. Yet another abortive effect can happen after implantation. "Removal of the corpus luteum from the human female during these early stages of pregnancy results in abortion . . ." — *Human Embryology*, W.J. Hamilton, MD, at 24. Once fertilization has occurred, studies show an abortion will result if the corpus luteum is removed prior to the 25th day of pregnancy. (Id.)

*What then happens when the pill has caused a woman's corpus luteum to be*

Atty. *deficient during the same critical period of time, and the synthetic progesterone in the pill is then suddenly removed from the woman's system at the end of the pill cycle?* It "leads to endometrial shedding." (Contracept. Tech., 14th Ed.) If a child has implanted into the womb, *it is a "menstrual abortion."* The child is "shed" with the lining of the womb. Only if the corpus luteum is secreting enough of the woman's natural progesterone, or the implanted child is secreting sufficient levels of his or her own progesterone, will the sudden withdrawal of synthetic progesterone at the end of the pill cycle not abort a child who has implanted. As a Co-Director of a large chain of pharmacies admits: "There is some probability that the egg will be fertilized prior to menstruation. That's what the pill does, it brings about menstruation" — It brings about an abortion. A woman never knows if her pill induced "mense" is the murder of a child.

### Hypocrisy and Deception:

One quick step to end this national deception is for the Attorney General's Office to ask Planned Parenthood and every physician, including those working for Nonprofit fiduciaries, the following questions: (1) What happens when an embryo is implanted in the womb and within the first week and a half of

## Christian Doctrine On "Conception"

"By his incarnation the Son of God ... reveals to humanity ... the incomparable value of every human person ... [as] the Word of God who was made flesh (cf. Jn 1:14) ... [I]n fact, 'from the time that the ovum is fertilized, a life is begun ... the life of a new human being ... [hence] the result of human procreation, from the first moment of its existence, must be guaranteed that unconditional respect which is morally due to the human being in his or her totality and unity as body and spirit. ... [R]ejection of human life, in whatever form that rejection takes, is really a rejection of Christ. ... 'Whoever receives one such child in my name receives me' (Mt 18:5)" — John Paul II, *Evang. Vitae*, see n. 60.

Christians believe as doctrine that Jesus ("Yeshua") was "Incarnated," becoming a human child like us in all respects (except sin), at all stages of development in the womb. As with normal fertilization, God united to Mary's egg cell the other half of Jesus' genetic code (DNA) that defined his physical development and appearance. "Incarnation" means Jesus was "created flesh" ("and the Word was made flesh"), and precludes any thought that The Word instead *invaded* or *possessed* a fertilized cell that was not Himself from the moment of fertilization. *That would be violence, not creation.* A cell that was other than Christ was not to become Him suddenly when it implanted into Mary's womb, but Christ became a fertilized cell — *an embryo*. He did not violate the life of another living cell (embryo), but He became a living human child as a cell, when it was created as Him. Incarnation *is the creation of a child* who is who He was as His first cell. It is absolutely necessary that it was a pure act of creation, and not one of the destruction or possession of another living cell. Christ's "conception" therefore requires that Christ was made a human being from the first moment a single cell of His physical life came into existence. *The Word was made flesh, and did not invade flesh.*

For a Christian to profess that implantation is the moment of "conception" and not fertilization, they

implantation you suddenly induce the "shedding" of the lining of the womb in an artificial 'period'? Answer: "It is an abortion." (2) If you (the physician) would never abort a fertilized egg, would you use the pill? Answer: "No, I would not." Case closed.

### Duty Of Care: 'Not Honesty Alone ...'

According to the Attorney General, a registered 'charity' who supplies birth control pills has a "heightened duty" of fiduciary care which requires of them "[n]ot honesty alone, but the punctilio of honor the most sensitive" in its dealings and representations to the community and each woman. It may not induce the use of its so called "services," nor to purchase its products, by practices which are "likely to mislead" a "reasonable" woman — let alone the vast percentage of women who believe human life is conceived at fertilization and that any drug that would cause the death or expulsion of a fertilized egg is an "abortion," not "contraception."

When the omission of certain information concerning the nature, effects, or mechanisms of a product would be misleading, qualifying information must be included in the advertisements. *FTC Policy Statement On Deception*. "Some cases involve omission or material information, the disclosure of which is necessary to prevent the claim, practice or service from being misleading." "As the Commission noted in the Cigarette rule, 'The nature, appearance, or intended use

of a product may create the impression on the mind of the consumer ... And if the impression is false, and if the seller does not take adequate steps to correct it, he is responsible for an unlawful deception." *Id.*, n. 9 "The issue is whether the act or practice is likely to mislead, not whether it causes actual deception." *FTC Policy Statement*.

Refusing to disclose that the pill induces changes or alterations in the woman's reproductive organs and cycle which are abortive, and which can in any month result in an abortion instead of the prevention of fertilization, is not the "punctilio of honor the most sensitive." It is not fiduciary "candor." It is patently deceptive. If a man was to deceive a woman by giving her what he knows or suspects is an abortifacient on a date telling her it is a "contraceptive," he would be put in jail for battery and rape, for having obtained her consent under false pretenses. But 'charitable' groups such as Planned Parenthood and physicians do it every day in the State of New Hampshire.

It is *commercial rape* for a profit — at the expense of women and their children. It is wrong.

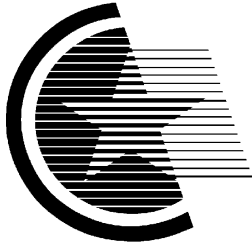
must be able to say to Christ: "Yes, I would give to Mary a pill that would prevent Your implantation for I would not be murdering a child, since You were not yet a human being while trying to implant into Mary's womb." It is a lie.

The Angel Gabriel announced to Mary that she would "conceive" a child, and that her cousin Elizabeth was already in "her sixth month" of pregnancy with her child, John the Baptist. Scripture says Mary set out to visit Elizabeth upon hearing this news, which scholars know was, traveling by foot, a two day journey<sup>(1)</sup>. Mary was not pregnant at the time Gabriel appeared to her. But she was pregnant at the end of the 2 day journey, at which the Holy Spirit in John the Baptist (Luke 1:15) caused John to "leap for joy" in Elizabeth's womb in recognition of the Christ child in Mary, in embryonic and pre-implanted state of development (2 days old).

All acts to prevent a fertilized egg from reaching or implanting into the womb or from being born is an abortion. No physician can claim to be "pro-life" and prescribe the pill. "Whatsoever you do to the least of these my brothers, that you do to me." (Matthew 25:40)

ones involved in the decision we are denouncing today, seem to believe that the people are no longer fit to govern themselves. One by one, on matters vital to the character of our communities, arrogant judges have legislated from the bench to impose on us that which would never have been approved through the legislative process.

Those of us who are pro-life are painfully aware of the repercussions of judicial activism. In *Roe v. Wade*, arguably the most blatant example of judicial activism, the Supreme Court invented a constitutional right to abortion, which was totally contrary to the will of the people. *Rock for Life* and *Crossroads* are two other divisions of American Life League that specifically target youth. *Rock for Life* reaches young people through the music industry. They present the message at Christian rock concerts. *Rock for Life* joined *Why Life?* as the music division in October 1998. *Rock for Life's* Executive Director, Bryan Kemper, has been a guest on the popular ABC talk show *Politically Incorrect* twice and was asked to be a regular.

Steve Sanborn, founder of *Crossroads*, started this unique ministry in 1995, his senior year of college. 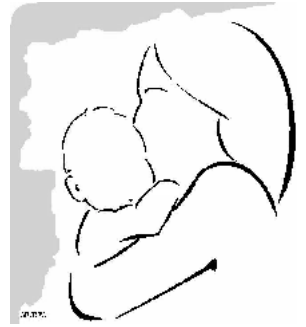

## Life Principles

We hold these truths to be self-evident: That all human beings are created equal by their Creator with certain inalienable rights, among which is the right to life; and therefore:

The right to life of each human being shall be preserved and protected by every human being in the society and by society as a whole, and

The life of each human being shall be preserved and protected from the biological beginning throughout the natural continuum of that human being's life by all available ordinary means and reasonable efforts, and

The life of each human being shall be preserved and protected at each stage of the life continuum to the same extent as at each and every other stage regardless of state of health or condition of dependency, and

The life of each human being shall be preserved and protected to the same extent as the life of each and every human being regardless of health or condition of dependency, and

When there is any doubt that there exists a human being's life to preserve and protect, such doubt shall be resolved in favor of the existence of a human being, and

When two or more human beings are in a situation in which their lives are mutually endangered, all available ordinary means and reasonable efforts shall be used to preserve and protect the life of each and every human being so endangered.
